DATA PROCESSING EQUIPMENT & MEDIA EXTENSION

- 1. COVERAGE EXTENSION Subject to limit(s) of liability and deductible amount(s) shown elsewhere in this policy and to all other terms, conditions and exclusions, this policy is extended to insure against direct physical loss caused by a peril insured that results in:
 - A. Mechanical breakdown of data processing equipment;
 - B. Electrical or magnetic injury or disturbance to data processing equipment or data processing data and media, including accidental erasure.

2. DEFINITIONS:

- A. "Data Processing Equipment" means electronic data processing equipment and its component parts, used in data processing operations.
- B. "Data Processing Media" means data stored on discs, films, tapes or similar electronic data processing media; the media itself; computer programs and instructions used in data processing operations.
- 3. VALUATION In the event of loss, the value of data processing equipment shall be the replacement cost (without deduction for depreciation).

The Company will not pay more for any loss on a replacement cost basis than the lesser of:

- A. The amount it would cost to replace the equipment at the time of loss with new equipment of equal performance, capacity or function and for the same use at the same location.
- B. The amount actually spent in repairing or replacing the equipment with new equipment of equal performance, capacity or function.

The Company will only pay any loss on a replacement cost basis if the equipment is repaired or replaced as soon as reasonably possible after the loss.

If the equipment is not repaired or replaced, The Company will not pay more than the actual cash value of that equipment.

In the event of loss, the value of data processing media will be the actual cost of reproducing the data and the cost of the media.

When the data is not reproduced, The Company will not pay more than the cost of blank discs, films, tapes or similar electronic data processing media, of the same kind and quality.

- 4. PROPERTY OF OTHERS In the event of loss to property of others in the Insureds care, custody or control, The Company will not pay more for any loss than the lesser of:
 - A. The amount for which the Insured is liable; or
 - B. The replacement cost of that property.

ALL OTHER TERMS AND CONDITIONS OF THIS POLICY REMAIN UNCHANGED.
